## A YEAR IN REVIEW

This annual report is intended to provide to the membership of Treaty 8 First Nations of Alberta an overview of the activities, challenges and successes of the Treaty 8 organization over the past fiscal year.

The report is divided into sections that cover off each of the activity areas. The first area is administration.

### ADMINISTRATION

The Executive of Treaty 8 First Nations of Alberta were faced with a serious challenge this past year. By September it became apparent that significant changes were going to have to occur quickly in order to protect the organization. The Executive called for an All Chiefs meeting in Slave Lake on October 9/10 to inform the full membership on the issues facing the organization and to seek their input on solutions. The following is a synopsis of the actions taken.

1. The Grand Chief resigned and the Vice-Chief assumed the role until elections could be held.
2. All spending was suspended pending confirmation of revenue and the approval of a management plan that would insure that the organization would survive and that all commitments would be honoured.
3. An interim Executive Director was appointed, in conjunction with the Tribal Council Executive Directors, to develop the plan and to provide the administrative leadership to ensure that the plan was followed.

### BYLAWS

One of the significant issues identified at the October 9/10 All Chiefs meeting was the need to review the Bylaws of Treaty 8 First Nations of Alberta and to revise sections of these Bylaws. A Special Meeting for the purpose of reviewing and revising the Bi-Laws was called for November 9 in Edmonton. A significant amount of preparation for this meeting had to occur and the Treaty 8 staff have to acknowledge and thank the staff from both the Lesser Slave Lake Indian Regional Council and the Athabasca Tribal Council for their valuable assistance in this regard. The Chiefs met
